FEE SCHEDULE FOR FOOD WHOLESALERS

The fee is based on the gross annual sales of ALL food wholesaled from the licensed place of business. If a food manufacturer operates food warehousing locations that are physically separate from any manufacturing location, the food warehouses must be individually licensed as warehouse operators. This includes facilities where food is held for limited periods of time.
