<sup>2</sup>PVD - Presumptive viremic blood donors are people who had no symptoms at the time of donating blood through a blood collection agency, but whose blood tested positive when screened for the presence of West Nile virus or Zika virus. Unless they meet the case reporting criteria, they are not counted as a case for official reporting purposes and are not included in the "Total" column.
