




Figure 2. WNV-Positive Mosquito Pools Reported in Texas, by MMWR Week of Collection, 2020-2022, Week 39




Figure 3. Human Cases of West Nile Virus Reported in Texas, by MMWR Week of Onset, 2020-2022, Week 39
