1. Call to Order

2. Introduction of guests

3. Adoption of the minutes of the May 23, 2014 meeting

B. Discussion of draft position statement on Storage of Spent Nuclear Fuel/High Level Waste in Texas

Mr. Hageman presented the advisory statement in Mr. Lucas' absence. Mr. Hageman made a motion to recommend approval of the advisory statement which was seconded by Mr. Krieger. The advisory statement was unanimously approved.

New Business

A. TRAB position statement on NRC's proposed changes to the safety regulations, 10 CFR Part 20

Mr. Hageman discussed the NRC proposed changes. Mr. Raabe, Mr. Hageman and Mr. Krieger, and Mr. Fleming will present opposition statements before the next meeting.

B. TRAB Position Statement on Disposal of Low Level Radioactive Waste (Sealed Sources)

Ken Krieger presented the advisory statement to the committee. Mr. Hageman motioned to recommend approval of the statement. Mr. Krieger seconded the motion and the advisory statement was unanimously approved, pending any necessary typographical and format corrections.

6. Public Comments

Rick Jacobi said there is no prohibition from using the bill of lading versus the waste manifest to identify sealed sources that may require disposal.
