

## **SAMS E-Authentication & Evaluation Web Access Instructions**

For any **new or existing employees** who have never been e-Authenticated please follow the instructions below.

For any employee who has been e-authenticated but has forgotten their password or is having difficulty logging into their account please contact the SAMS help desk at [samshelp@cdc.gov](mailto:samshelp@cdc.gov).

### **Step 1: E-Authentication**

To become e-authenticated please send an email to Lourdes Gordillo at [hkq7@cdc.gov](mailto:hkq7@cdc.gov) with the following prompt. "My name is XXXX from XXXX, a contractor of Texas Department of State Health Services, I need to be e-authenticated to gain access to EvaluationWeb for HIV Testing".

In the days following your initial e-mail to Lourdes Gordillo you will receive an invitation to register with the CDC's [Secure Access Management Site \(SAMS\)](#) "SAMS No-Reply (CDC)." This invitation will include instructions on how to complete the requirements needed to gain access to EvaluationWeb. Note that the registration process requires each user to have their application notarized by an official notary republic and requires two forms of identification.
