- Mr. Jeff Mantia – DSHS youth Camp Update.
 - 100% review of Background checks and sexual molestation awareness trainings of 32 randomly selected youth camp.
 - Sexual Abuse and Molestation Awareness training certificate or exam need provider name and approval number to verify as an approved DSHS course.

Discussion:

- Background checks have by rule: use local, state, and national databases.
 - Concern with the varying cost of the different agencies providing background check.
 - Committee Members have concern with private information being release due to an open records request.
 - Guidelines for inspectors. Would like clear guideline on what information is required in the field and submission to central office.
 - Will the random selection be up for discussion was continuing random selection of youth camps? Unknown at this time by the department.
 - Under statue we have the ability to have copies of specific documents for retention and record and request all.
 - Possible disclosure to employees at time of employment. And who can ask for the information and who can review - guidelines.
 - Creation of DSHS Policy within the agency on which personnel will view Background report information and Criminal information.
 - 32 selected youth camps had no problems with the random selection and background checks review.
 - Concern that some checks result in 'hits' for individuals with similar names or birth dates.
 - DSHS would need documentation of the individuals with similar names or birth dates to prove the individual in question has a clear background check.
- Program revision of Youth Camp Rule Chapter 265 subchapter (B)
 - New Definition – Challenge Course
 - Hazardous Activity definition – revised to Youth Camp Activity.
 - Possible change of general characteristics of the youth camp.
 - Removal of OIG to report incidents of abuse or neglect of a minor
 - Abuse or neglect of a minor offsite, refer to family code.
 - Open Discussion – appointment of committee members. Some of the Committee Members terms have expired and did not attend the meeting. The executive commissioner must approve committee members.
 - Public Comment
 - Courtney Hoffman – reporting of abuse or neglect of a minor at a youth camp to the department. 'The Department' is defined but can we add a contact

information. To be clear and give the exact information so it is easier for people to report.
